Le programme de travail dans Horizon Europe

- Horizon Europe is implemented through **work programmes** which set out funding opportunities mainly through **calls for proposals**.
- A call for proposal will normally contain one or more **topics** with a common deadline. The budget of the call is distributed among topics. Where topics share a budget envelope, proposals for these topics will be competing against each other and will result in a single ranking list.
- Applicants **apply to a specific call and topic**.
- Each topic to which applicants can apply will include:
 - The topic **scope**
 - The topic **expected outcome**
 - The **expected impact** of the destination to which the topic belongs
 - The **type of action**
 - The topic **budget** (or budget shared by group of topics)

3 critères principaux sont évalués : excellence, impact, qualité et efficience de la mise en œuvre

☑ Évaluation par les pairs

Comités d'experts indépendants, les « experts-évaluateurs »

Chaque projet est évalué par minimum 3 experts

Les projets sont classés et financés par rapport au budget disponible

☑ Duré de l'évaluation

5 mois maximum (+3 contractualisation) = 8 mois de la date limite au début du projet «*time to grant*»

Excellence

Clarté et pertinence **des objectifs du projet**; et dans quelle mesure ils sont ambitieux et vont au-delà de l'état de l'art

Crédibilité de la méthodologie proposée, notamment les concepts sous-jacents, les modèles, hypothèses, approches interdisciplinaires

Considération appropriée du **genre dans le contenu de la recherche**

Qualité **des pratiques de science ouverte**, notamment l'engagement des citoyens, de la société civile et des utilisateurs finaux et gestion et partage des résultats de la recherche

Impact

Crédibilité de la voie choisie (*pathway*) pour atteindre les « outcomes » et « impacts » attendus listés dans l'appel et le programme de travail et dans quelle mesure le projet va y contribuer

Adéquation et qualité des mesures pour maximiser les impacts et résultats attendus, tels que décrit dans **le plan d'exploitation et de dissémination**, notamment les activités de **communication**

Mise en œuvre

Qualité et efficacité **du plan de travail**, évaluation des risques et adéquation des efforts assigné à chaque « work packages » et les ressources

Capacité et rôle de chaque participant, et dans quelles mesures le consortium dans son ensemble apporte l'expertise nécessaire

Les notes des évaluations



Répartition des notes RIA













Projets financés - moyenne des notes par critères







Soundness of the concept

Méthodologie

Exemple de critiques négatives sur la méthodologie des projets

- *There is a concern about the large number of instruments and items and it is not clear how many they will be used in practice*
- *the collection of samples, as described in the methods, is challenging especially for the proposed sample size*
- *the proposed methodology has a shortcoming related to the experimental models, which are insufficiently described and difficult to translate to human health.*
- *some concepts and the integration of different methods and expertise are inadequately demonstrated*
- *Aspects such as the establishment of the biobanks or the modelling aspects are insufficiently elaborated*
- *convincing data are not presented supporting the assumption*
- *characteristics of the study population are not clearly described including if and how the project will target high-risk groups for the interventions*
- *The proposal lacks details regarding the validation of the new diagnostic test.*
- *Although the scientific methodology is clear and sound, it is not always sufficiently detailed.*



Soundness of the concept

Interdisciplinarité :

Dans la plupart des cas, les remarques négatives sur l'interdisciplinarité soulignent le manque d'expertise ou d'intégration des Sciences Humaines et Sociales

→ *Problème en particulier pour la Destination 4, destination avec les plus nombreuses critiques sur cet aspect*

Open sciences practices

Engagement of citizens, civil society, and end-users where appropriate : 17% des commentaires positifs

Exemple cités : highly developed co-creation design, consultations with adolescents, parents and staff and development of advisory committees, involvement of patient advocacy group, engagement of end-users in usability tests

Artificial Intelligence

Commentaires positifs

Solid AI methodology, robustness sufficiently discussed/ well-described / well demonstrated

Commentaires négatifs

AI solution is not sufficiently described

the robustness of the AI tools to be used is not clarified in sufficient details / not adequately addressed

The proposal indicates that AI and Machine Learning will be used without sufficient information about the models, techniques and the approaches that are proposed
insufficient details on the justification of the use of AI

Clinical Trial/Studies

Commentaires positifs

- *The retrospective and prospective cohorts to be used for validation are well described including sample availability, while possible regulatory obstacles are realistically identified*
- *All studies are designed to the specificities of the settings, regions and target groups, with adequate detail provided*
- *clinical study is professionally described, designed extremely well, scientifically sound, structurally excellent, planned robustly and operationally highly feasible*

Commentaires négatifs

- *is not clear whether the number of subjects in the clinical study will allow prediction of the health-to-disease transition and whether the study is of sufficient complexity*
- *there are concerns that the number of participants of the study to understand youth perceptions of exposures relevant to mental health conditions does not adequately cover the diversity of target group*
- *the clinical study document does not provide sufficient information on power calculation.*
- *the study design, variables and sample size estimations lack specification*
- *Some part of the protocol is unclear, how and why the timing for treatment has been chosen*

Remarques Générales : Impact

Pathway to impact

Beaucoup de commentaires sur cet aspect

Exemple de commentaires négatifs

- *the proposal fails to convincingly elaborate the path to get to the expected outcomes and impacts considering policy recommendations, treatment guidelines related to regulatory principles and involvement of patient groups.*
- *details on the specific pathways (on how the expected contributions will be achieved) are lacking, for example, on stakeholder engagement, citizen science.*
- *the deployment of the proposal outputs at a broader European level among member states and decision-makers at various member state levels are not convincingly presented*
- *the proposal does not clearly define the targets/validation for some KPIs and how they will be monitored and assessed*
- *the obstacles related to social risks are not sufficiently covered*
- *there is insufficient evidence how mental health outcomes will lead to potential impact*



Pathway to impact

Beaucoup de commentaires sur cet aspect

Exemple de commentaires négatifs

- *given the complexity of the proposed action, the proposal has devoted insufficient attention to some further possible barriers*
- *barriers in achieving impacts are insufficiently detailed beyond research activities*
- *the potential lack of acceptance or adoption of the outcomes by Regulatory or HTA agencies is an important barrier that is not sufficiently considered.*



Remarques Générales : Impact

Plan de dissémination, communication et exploitation

Près de 30% des commentaires positifs sur les plans de dissémination et communication soulignent l'identification de **groupes cibles différents** et l'adaptation du plan à chacun d'entre eux

- Exemple de groupes cibles cités : healthcare professionals, patients, researchers, clinicians, citizens, decision makers, different level (local, regional, global), industrial stakeholders, networks of excellence
- Exemple de voie de dissémination communication citées : newsletter, events, social media, seminars, policy papers, training and education materials, workshops, open data sources,

Remarques Générales : Mise en œuvre

Work plan

25% des commentaires négatifs concernent l'allocation des ressources

- *Resources distribution per partner, task leaders and work packages are not well balanced*
- *the high level of person months allocated to the coordinator is not convincingly justified*
- *the overall effort of the project is underestimated*
- *the resource allocation does not correspond to the planned work, is insufficiently justified*
- *some major direct cost items are insufficiently detailed*

17% des commentaires négatifs concernent le timing du projet :

- *the timing of the tasks is not specified*
- *all WPs start in month 1 and end in month 48.*
- *the timeline is likely too ambitious to complete the proposed tasks*
- *the planning in terms of timing and sequencing of WPs and tasks may not contribute to the effective execution and evaluation of the project.*
- *the timing that has been allocated to the tasks is not well aligned with the objectives / underestimated / not specified*
- *the proposed duration of the project has not been sufficiently justified.*



Work plan

15% des commentaires négatifs concernent le suivi du projet :

- *the work packages (WPs) do not provide enough quantified information to monitor progress*
- *the number of milestones is insufficient to allow adequate monitoring of the project's progress*
- *milestones are not related to deliverables. This makes the monitoring of the project difficult*
- *the number of deliverables is too limited to enable an adequate progress tracking*
- *the proposal is expected to include many deliverables that are not publicly available, which is a concern*
- *the breakdown in work packages (WP) is not fully appropriate to monitor the progress of this project*
- *not all milestones have a due date specified / insufficient milestones to enable appropriate monitoring of implementation progress.*
- *most deliverables and milestones are scheduled for the final months of the project and intermediate control points are not obvious in the plans*



Work plan

25% des commentaires négatif concernent la description technique des WP:

- *dissemination is split between WP0 and WP6*
- *the logistics and delivery approach that will be used for the transport of specimen is not convincingly described*
- *There is lack of details concerning the implementation of WP1*
- *the proposal does not sufficiently define how the primary data of the three pilot will be collected*
- *Some implementation aspects are insufficiently detailed. For example, the process to define and agree on a minimum viable product and aspects of trustworthiness*
- *there is limited information about the standardisation/harmonisation status of existing data and about any measures to address potential lack of standardised data among the data providers*
- *The description of the work packages is insufficient*
- *the proposal provides insufficient implementation details on each of the envisaged pilot studies*

Risk Analysis

Commentaires positifs

Critical/potential risks are well identified and appropriate mitigation measures proposed
Risk assessment is well presented / very good

Commentaires négatifs

The risks are inadequately addressed / not sufficiently elaborated

The list of risk is not exhaustive, too general

Mitigation measures are not sufficiently explained / not fully convincing



Consortium

Exemple de commentaires négatifs

- *The availability and the access to the necessary infrastructure is not clearly described*
- *The roles of the partners are not always balanced across the execution of this project / is not sufficiently clear or justified*
- *Lack of expertise in specific fields (health economics, psychology, HTA bodies, clinical, Social Science and Humanities, etc.)*
- *the project does not provide a significant industrial/commercial involvement to ensure exploitation of the results*



Pathway to impact : too generic, not enough detailed, lack further justification, fail in demonstrating the impact, not quite convincing


KPI not sufficiently described or not convincing

Likely scale and significance : not sufficiently evidenced


Exploitation Strategy : not clear, not sufficiently explained, lack specific details
