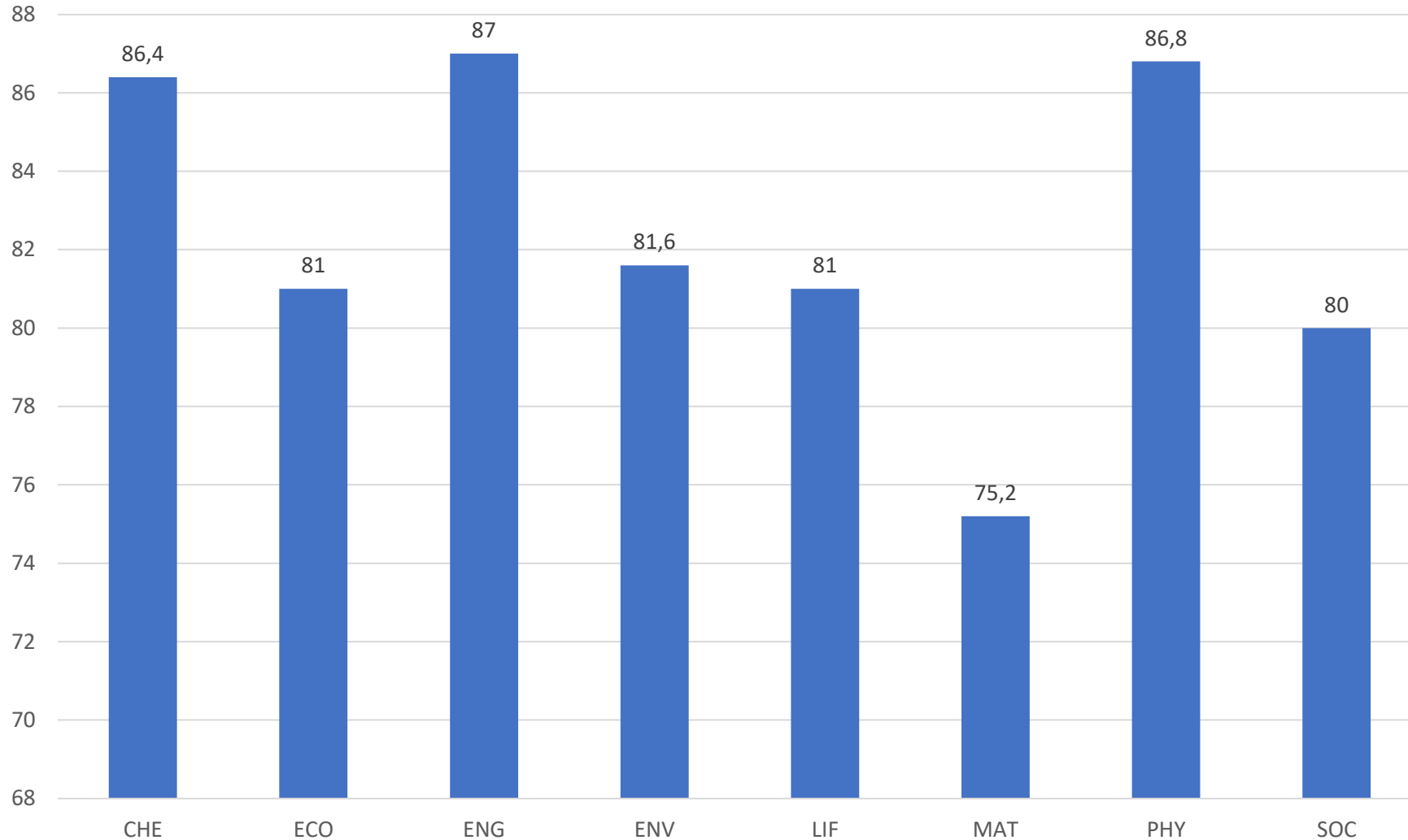

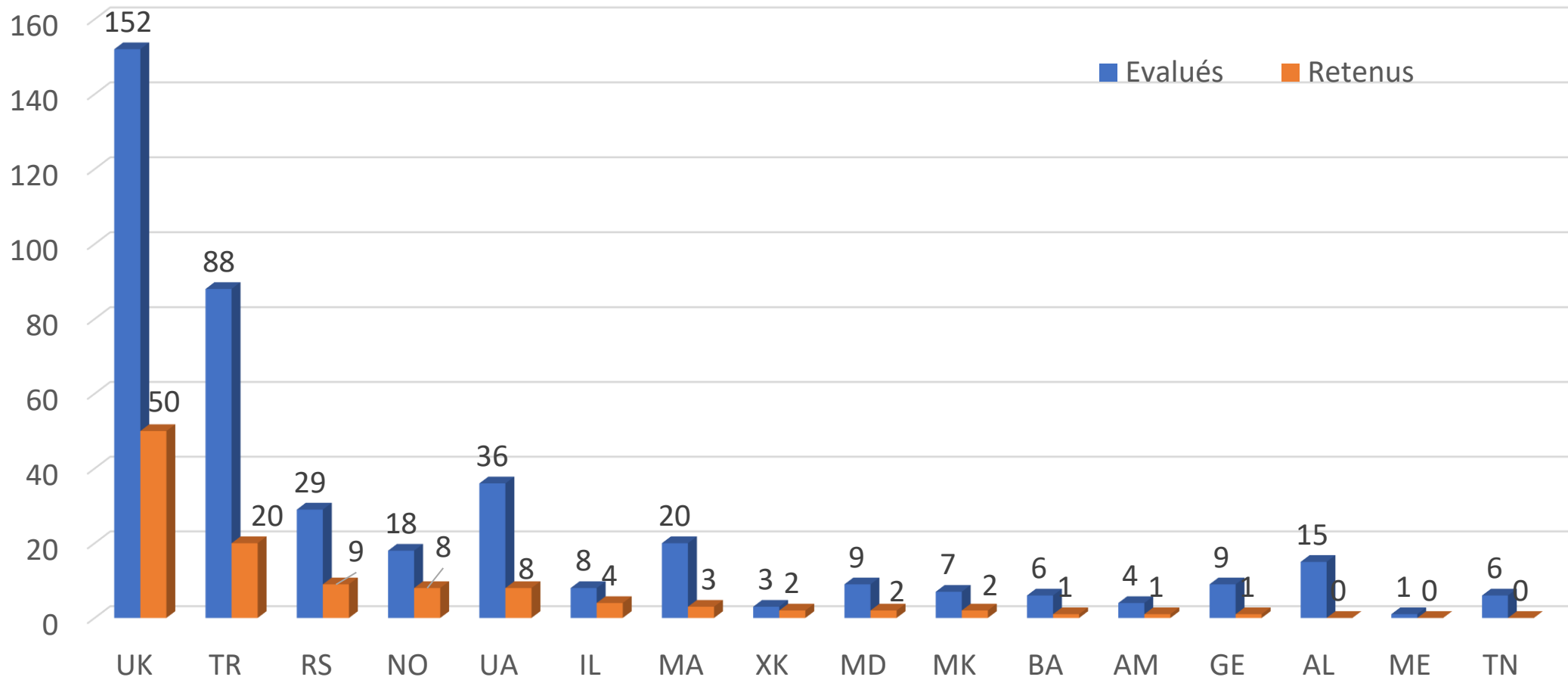

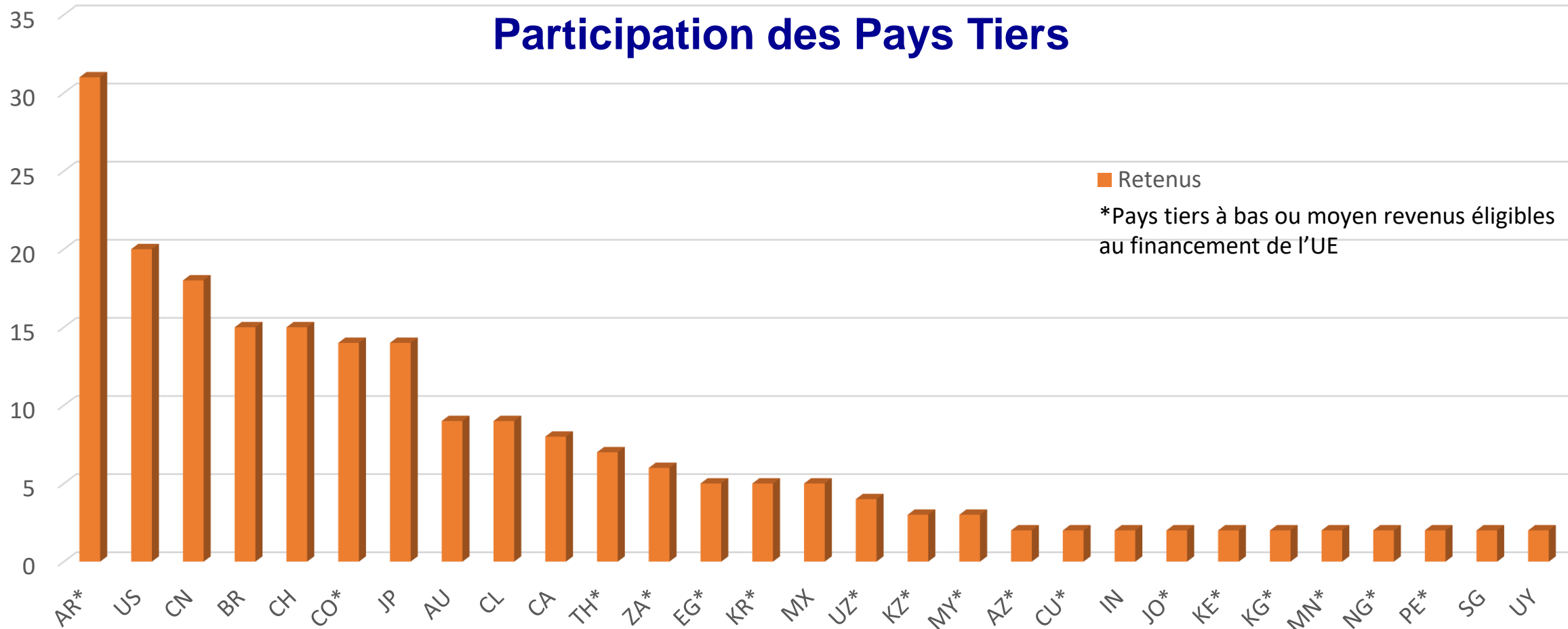
Participation des Etats Membres

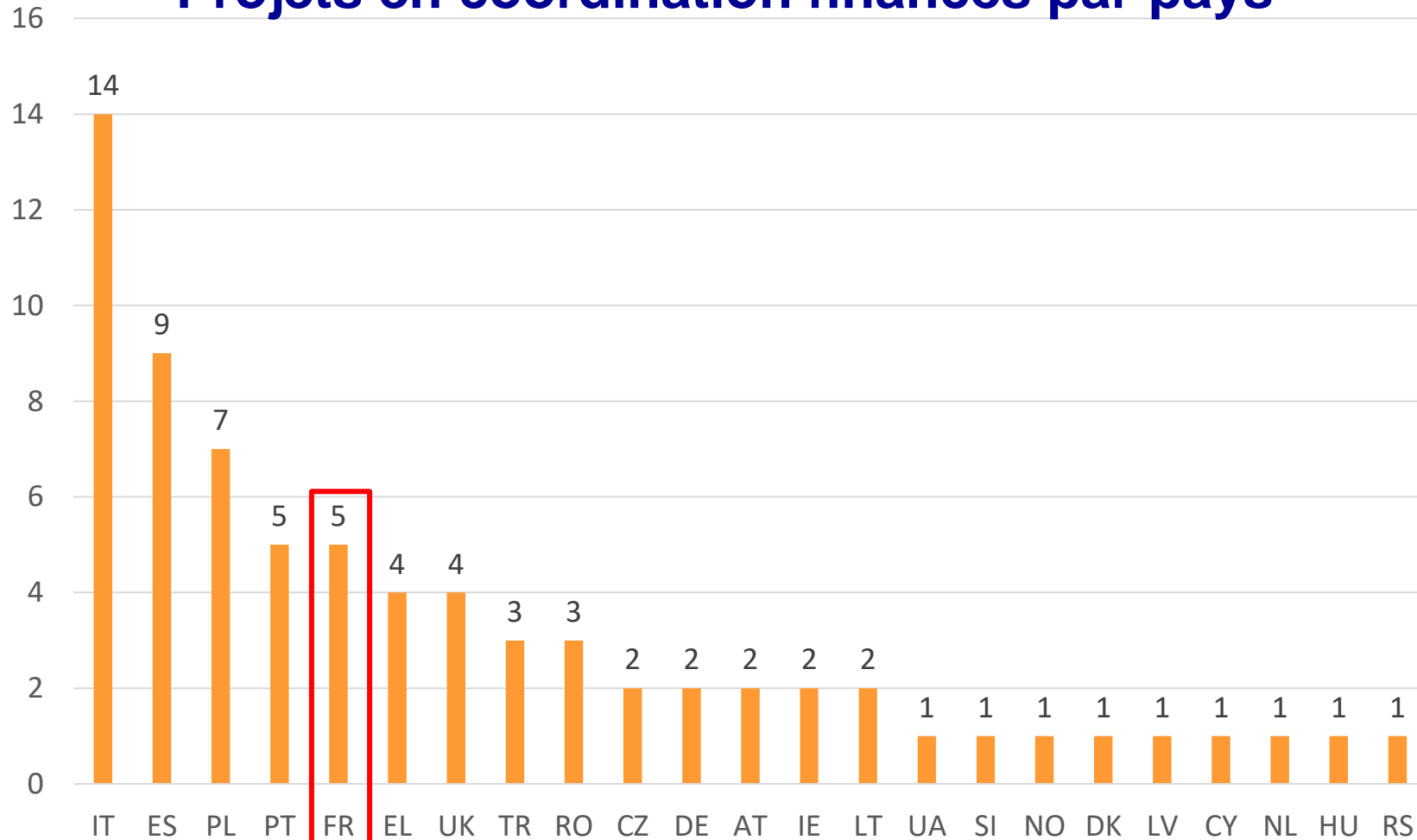

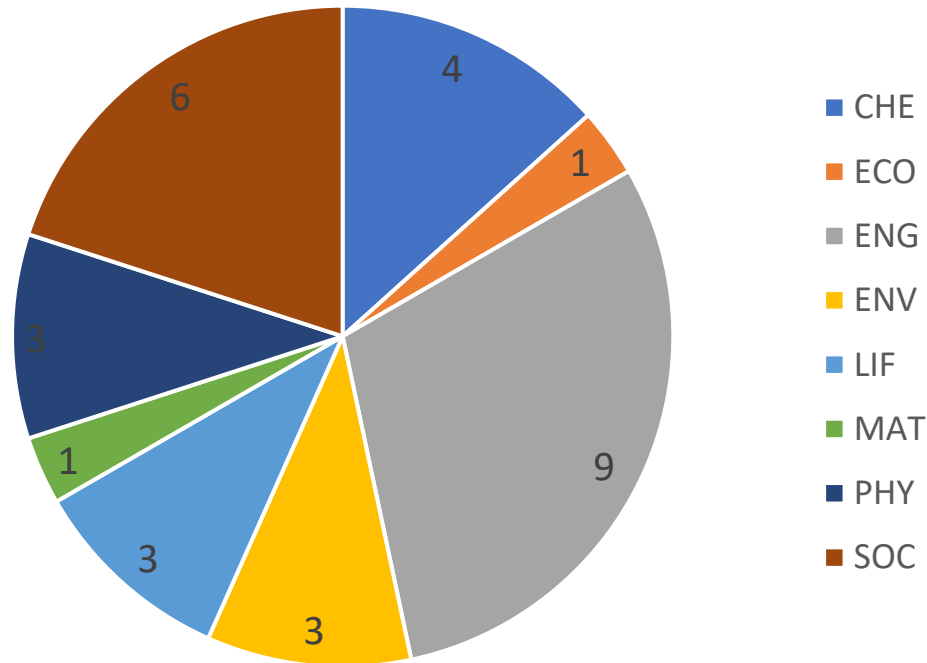
